Guidelines for Mime Show competition:

- The file can be in MP4 format.
- The resolution must be 1080p HD pixels for the sake of clarity and precise judgment.
- The mime show video shall be prepared with the maximum duration of 5 minutes and shall be sent to mail id econeventsu@gmail.com on or before 12.01.2026
